## STRATEGY

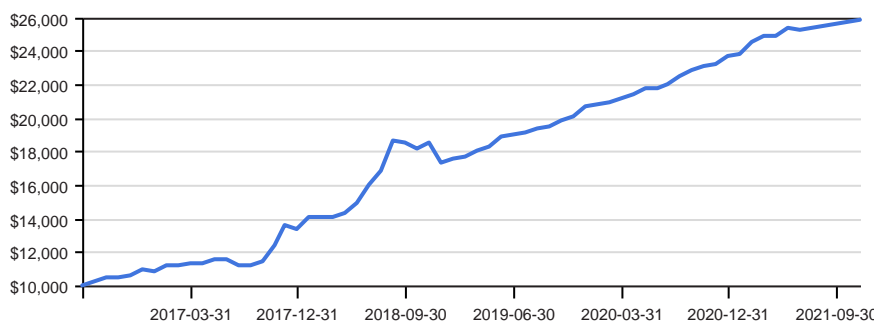

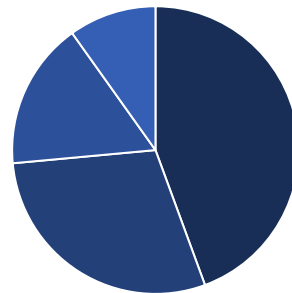
