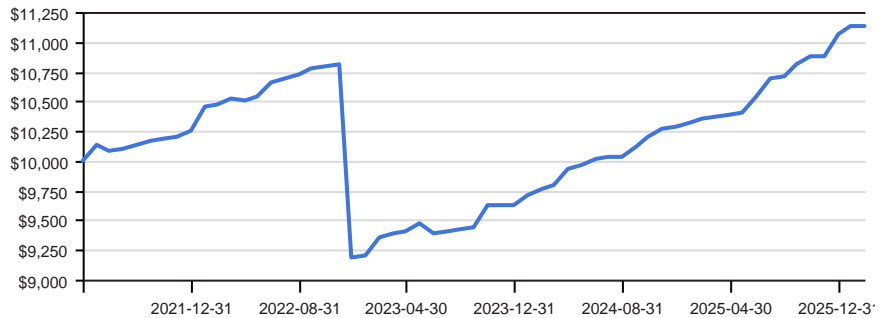

## STRATEGY<sup>1</sup>

The investment objective of the Trust is to seek to generate superior returns through investments that the Manager believes have the potential to provide substantial upside. The Trust will invest a minimum of 80% of its net assets at cost in the AIP Convertible Private Debt Fund LP (AIP Convertible Private Debt Fund). Currently, 100% of the Trust's net assets are invested in the AIP Convertible Private Debt Fund. The investment objective of the AIP Convertible Private Debt Fund is to seek to general superior returns through activist investments in investee issuers with a primary focus on convertible private debt securities. The manager of the AIP Convertible Private Debt Fund limits the cost of its holdings of equity securities to 20% of its net assets. The manager of the AIP Convertible Private Debt Fund has a broad mandate of identifying attractive investment opportunities that includes, but are not limited to, seed capital, small capitalization investments, private placements, and debt instruments. The AIP Convertible Private Debt Fund may acquire control positions (greater than 20%) in investee issuers.

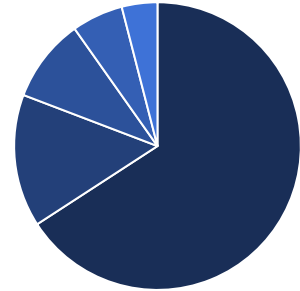
